The protection of the common area property, neighboring properties, and Developer's property is the responsibility of the applicant. If any damage is done to the common areas of the property or neighboring properties, it will be the responsibility of the applicant to make appropriate repairs.

2. *Minor alteration or addition* – modifications of a relatively insignificant nature, including shutters, exterior paint change, screened front porch, solar panel installation, satellite dish request or fence request.
