THE BOULEVARD TENNIS CLUB

MEMBERSHIP AGREEMENT TERMS AND CONDITIONS

1. **MEMBERSHIP.** Your membership is a contractual privilege to use The Boulevard Tennis Club ("Club") premises, facilities, equipment, services and programs and participate in club sponsored activities and events (collectively called the "Club Facilities") offered from time to time by the club to members during the Club's published hours of operation. The Club reserves the absolute right without notice to initiate, change or eliminate any Club Facilities offered from time to time, to initiate, change or eliminate fees for existing or new Club Facilities; and to change its hours of operation. Your membership does not entitle you to any interest or ownership in the Club or its property and confers no right to participate in the management or operation of the Club. The classification of members, the amount of initiation fees, dues and other charges payable by the members, the suspension and termination of members, and all other matters affecting or relating to your membership shall be under complete control of the Club.
2. **CATEGORIES OF MEMBERSHIPS**
 - a) **Single Silver Membership.** A single membership consists of one person, 19 years of age or older.
 - b) **Family Silver Membership.** A family membership consists of a primary member and another family member or domestic partner and/or dependent children under the age of 24 residing in the same household on a permanent basis or in college full-time.
 - c) **Gold Memberships.** The Gold memberships include the privileges of a Silver Single or Family Membership with additional benefits and discounts on club services as stated on the membership categories information sheet.
 - d) **Senior Memberships.** Same privileges as the Silver or Gold memberships, depending on the type of Senior membership you choose, with one exception. You must be 65 or older in order to be eligible for the Senior memberships. A Senior Family membership requires that both parties must be 65 or older.
3. **BYLAWS.** Your membership is subject to compliance with the Bylaws of the Club, which may be amended by the Club from time to time. All signs and other rules and regulations posted in or distributed by the Club shall be considered part of the Bylaws. Bylaws may be changed, supplemented, or amended at the sole discretion of the Club, as deemed necessary for the proper management of the Club. The Bylaws shall be considered a part of this membership agreement.
4. **FEES AND CHARGES**
 - a) **Initiation Fees.** In consideration of your Gold Membership, you will pay a non-transferable, one time Initiation fee to the Club. The initiation fee is non-refundable after the expiration of the applicable cancellation period in accordance with Section 6(a). If you cancel your membership and elect to rejoin the Club at a later date, you will be required to pay a reinstatement fee that will be determined by the Club. The Club reserves the absolute right at any time to change the amount, manner and time of payment of the initiation fee. The initiation fee and prorated dues must be paid by check or credit card.
 - b) **Dues and Other Charges.** Members may sign for additional facility services and/or merchandise ("Member Charges") and have them included in their monthly billings. Statement of monthly Member Charges will be mailed at the beginning of each month. Gold members are responsible for children listed on their membership application. Florida state sales tax will be added to all initiation fees, membership dues, and other member charges as required by law. Your membership and your payments will begin when this Agreement is signed by you and will continue unless otherwise terminated in accordance with Section 6. You understand that the failure to use the Club will not relieve you from paying dues and other charges that become due. The Club reserves the absolute right at any time to increase membership dues and other charges for services offered by the Club.
5. **PAYMENT METHOD**
 - a) All initiation fees and Annual dues will be paid by check or credit card. All monthly charges accrued on your member account may be paid with a check or credit card.
 - b) **Late or Returned Payments.** The Club may assess late payment fees and service charges for returned checks. There will be a \$45.00 fee per declined transaction. If any payment of dues or other charges is not made on time, the Club reserves the right to suspend charge privileges and cancel your membership. The Club reserves the right to refer delinquent accounts to a third party collection agency and you agree to pay for all costs incurred including, but not limited to, attorney's fees and administrative costs. Any payment not made within thirty (30) days shall be subject to a 2% late fee per month.
6. **CANCELLATION RIGHTS AND REFUNDS**

- a) **Cancellation by Member.** A Gold member has the right to cancel within 3 days of their sign up date and receive their initiation fee back. If you cancel your membership and elect to rejoin the Club at a later date, you will be required to pay a reinstatement fee that will be determined by the Club.
- b) **Cancellation by the Club.** The Club reserves the right to terminate any membership for violation of the Club Bylaws or other rules and regulations of the Club by notice to you. Any removal or defacement of Club property or another member's property will result in immediate termination. You will remain liable for all unpaid dues and other charges for periods prior to the termination date. Any member or guest, who, in the sole determination of the Club, is loud, offensive, uses profanity, is bothersome to other members/employees or behaves otherwise in an inappropriate or unbecoming manner or who is cited for infraction of the Club Bylaws may be suspended or terminated from the Club.
7. **SEPARATION/DIVORCE.** In the event a Club membership is held by a married couple who subsequently are legally separated or divorced, all privileges, benefits, and obligations of the Club membership shall be awarded to one (1) spouse as set forth in the separation agreement or divorce decree. In the absence of a written separation agreement or divorce decree, the membership shall continue in the name of the primary member listed on the membership application. During the pendency of divorce or separation, the Club, in its sole discretion, may suspend charging privileges of the Member, if any problem with payment of the bill should occur. The spouse who is not awarded the membership may apply for membership in the same manner as any new applicant for membership.
8. **PHYSICAL ACTIVITY READINESS.** You, on behalf of yourself and any member's family, and guest(s) represent that, (1) you, your family, and guest are voluntarily engaging in physical exercise, are in good physical condition and have no disabilities, diseases, illnesses or other conditions that could prevent you or your family or guest(s) from exercising and using the Club Facilities without injuring yourself/themselves or impairing your/their health; (2) you have consulted a licensed physician concerning an exercise program that will not expose you to risk of injury or impairment to your health; and (3) your physician has approved your contemplated activities at the Club.
9. **LIABILITY WAIVER.** You and your guests must sign The Boulevard Tennis Club Waiver and Release from Liability form prior to using the club facilities and services. A signature from a parent or legal guardian is required for all children under the age of 18.
10. **LIMITATION OF LIABILITY.** You understand and agree that the Club is not responsible for loss, damage, or theft of personal property of members or guests while in or on the Club premises.
11. **ENTIRE AGREEMENT AND MODIFICATION.** This Agreement constitutes the entire agreement between you and the Club relating to your membership. You acknowledge that no other agreement exists between you and the Club relative to your membership and that no representations whether written or oral, other than those set forth in this Agreement, have been made to you to induce you to make this Agreement. This Agreement can be modified only in writing by the Club and can be terminated only as set forth herein. You further agree this Agreement is intended to be as broad and inclusive as permitted by the laws of Florida, that it shall apply to any period of membership or any prior or subsequent membership period of yours or any dependent, and any period during which you or any dependents use of the Club Facilities.
12. **COSTS AND ATTORNEYS' FEES.** If any action, suit, arbitration or other proceeding is brought relating to the enforcement or interpretation of this Agreement, the prevailing party shall cover all of such party's costs incurred therein, in collection of any judgment, enforcement of any indemnity rights, and in all appeals or petitions there from, including, without limitation, court costs and reasonable attorneys' fees. This section shall not be deemed to provide for the award of attorneys' fees for personal injury or non-contractual claims.
