By virtue of this Section 15.2 and in order to afford all beneficiaries of the Beach Access Easements the benefits thereof, there shall be the absolute and unabated right to use, cross over, ride on or otherwise access on foot or any vehicle the right of way, roads, sidewalks or other suitable Common Areas located

anywhere reasonably necessary within the Phase 1 platted lands in The Strand at Indian River Shores for, among others, all individual owners in The Strand at Indian River Shores and their guests, tenants and/or invitees to use the Beach Access Easement..
